RESOLUTION 25-20

BRIDGE EMBARGO

WHEREAS: The Board of Supervisors is empowered under the authority of Sections 306.10, 321.236 Sub. (8), and 321.471 to 321.473 of the Code of Iowa to prohibit the operation of vehicles or impose limitations as to the weight thereof on designated highways or highway structures under their jurisdiction, and

WHEREAS: the Mills County Engineer has completed (or has caused to be completed) the Structural Inventory and Appraisal of certain bridges in accordance with the National Bridge Inspection Standards and has determined (or it has been determined) that they are inadequate for two-lane legal loads at allowable operating stress.

NOW, THEREFORE, BE IT RESOLVED by the Mills County Board of Supervisors that vehicles and load limits be established and that signs be erected advising of permissible maximum weights thereof on the bridges listed on the following page.

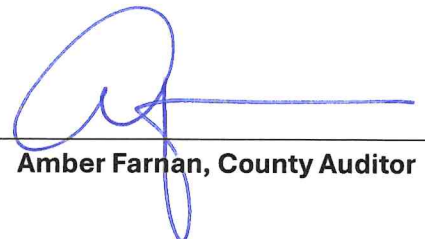
